I acknowledge that the sport of horseback riding is high risk and that I am participating at my own risk and in full knowledge of the hazards and potential hazards which are inherent in this sport. I further acknowledge the inherent risks in riding and working around horses, which risks include bodily injury or death to both horse and rider, which can result from normal use, competition or schooling.

I acknowledge that the inherent risks of horseback riding means those dangers or conditions which are an integral part of equine activities, including, but not limited to: The propensity of an equine to behave in ways that may result in injury, harm, or death to persons on or around them; The unpredictability of an equine's reaction to things such as sounds, sudden movement, and unfamiliar objects, persons, or other animals; Certain hazards such as surface and subsurface conditions; Collisions with other equines or objects; and The potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability.

In consideration of being allowed to participate in this event and on this property, I hereby assume all risk and I hereby release and absolve Heads Up! Equestrian Services, Trendsetting Services Inc, Trendsetting Stables, and their officials, volunteers, and instructors and the owners and occupiers of the land upon which the equine event is held from all responsibility, liability or claims of any nature and kind which I may have arising from my participation in this activity, including but not limited to bodily injury or death to myself or my horse(s) and damage to property arising from any cause whatever, including the negligence of one or more of the individuals and organizations referred to herein.

- C. **Under 10 years old – Walk/Trot/Canter** (no cross entry between B and C)
- D. **10 – 14 years old Equitation**
- E. **15 – 18 years old Equitation**
- F. **Open Under Saddle** (note- canter will be required)

Indoor arena will be available for warm up area.

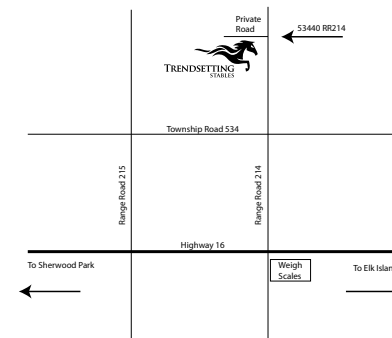
All competition footing is sand.

In case of rain the jumping classes will be run indoors.

There will be **no stabling** available.

#### Rules:

1. No abuse or excessive discipline of any horse will be tolerated at this show.
2. All riders must wear an ASTM/CEI approved helmet when on a horse at any time.
3. Please leave your dogs at home.
4. Please follow the Equine Canada guidelines for acceptable tack and turn out for the classes being entered.
5. Please be respectful of our volunteers and officials.
6. The management of this show reserves the right to limit entries in order to facilitate a manageable length of day.
7. All riders **must be members** of the Alberta Equestrian Federation in order to participate. (this is for insurance purposes) To acquire your AEF Membership online go to [www.albertaequestrian.com/](http://www.albertaequestrian.com/). Please note that you must have your membership number on your entry form.
8. No postdated cheques please.
9. Waivers must be signed by the Parent/Guardian, **not the trainer**.
10. Stake class may be entered if horse/rider is entered in **at least** one other class of the division.
11. Entries **received** after August 16<sup>th</sup> will be subject to a \$25.00 post entry fee.
12. Returned cheques will be subject to a \$25.00 fee.
